**PRIMARY ROUTES OF ENTRY:** a) Skin b) Inhalation

**MEDICAL CONDITIONS AGGRAVATED BY EXPOSURE:** Pre-existing skin, eye and respiratory disorders may be aggravated by exposure to product.

**EMERGENCY FIRST AID PROCEDURES:**

- A) Skin – Immediately flush skin with lots of running water for at least 30 minutes. Remove contaminated clothing and shoes. Wash before reuse.
- B) Eyes – Flush immediately with large quantities of water for at least 15 minutes. Consult physician.
- C) Inhalation – If affected, remove individual to fresh air. If breathing is difficult, administer oxygen. If breathing has stopped, give artificial respiration. If breathing is difficult, administer oxygen. Keep person warm, quiet and get medical attention.
- D) Ingestion – Do not induce vomiting. Call physician immediately. If conscious give lots of water or milk. Do not give anything by mouth to an unconscious or convulsing person.

#### **SECTION 6 – SPILL OR LEAK PROCEDURES**

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED:

#### **SECTION 8 – SPECIAL PRECAUTION**

PRECAUTIONS TO BE TAKEN IN HANDLING AND STORAGE:

A) Do not store near acids or acidic materials and oxidizers.

B) Do not store under freezing conditions or above 120 degrees F.

C) Protect from physical damage and keep tightly closed.

D) Keep away from heat, sparks and open flames.

MAINTENANCE PRECAUTIONS:

When working with FLAMMABLE material electrically ground all equipment and use only non-sparking tools.

OTHER PRECAUTIONS:

Containers, even those that have been emptied will retain product residue and vapors. Always obey hazard warnings. Always ground metal containers while pouring.

ADDITIONAL COMMENTS:

- Unusual Fire and Explosion Hazards

A) Never use welding or a cutting torch on or near container (even empty) because product (even just residue) can ignite explosively.

B) All 5 gallon pails and larger metal containers should be grounded when material is transferred
